

Following the decision of Cabinet today, I have appointed a Committee to deal with alleged corruption of all procurement, including Personal Protective Equipment (PPE), sourced for the purposes of containing and responding to the COVID-19 Pandemic.

The Committee is comprised of the following members:  
The Minister of Justice and Correctional Services as Chairperson  
The Minister in The Presidency  
The Minister of Finance  
The Minister of Police  
The Minister for Public Service and Administration  
The Minister of Cooperative Governance and Traditional Affairs

In this regard, I request your full cooperation in providing all information related to names of companies and amounts of tenders and contracts that have been awarded in your respective departments (and entities) during the period of COVID-19 and National State of Disaster.

These lists must be provided to the above committee as a matter of urgency this week. The Committee will prepare a comprehensive report and I intend to release this information publicly.
