SUPPLY CHAIN MANAGEMENT: THRESHOLD VALUES FOR THE PROCUREMENT OF GOODS AND SERVICES BY MEANS OF PETTY CASH, VERBAL / WRITTEN PRICE QUOTATIONS AND COMPETITIVE BIDS

#### 1 PURPOSE

The purpose of this circular is to obtain proposals from national and provincial departments, constitutional institutions and public entities listed in schedules 3A and 3C to the PFMA regarding the threshold values for the procurement of goods and services by means of petty cash, verbal / written price quotations and competitive bids.

#### 2 CURRENT THRESHOLD VALUES

2.1 Practice note number SCM 2 of 2005 dated 10 May 2005 issued by the National Treasury in terms of Treasury Regulation 16A6.1 prescribes that accounting officers / authorities should apply the following threshold values when procuring goods and services:

Range of Procurement	Threshold value (Including VAT)
Petty cash	Up to a value of R2 000
At least three verbal or written quotations	Above the value of R2 000 but not exceeding R10 000
Written price quotations	Above the value of R10 000 but not exceeding R200 000
Competitive bids	Above the value of R200 000

2.2 These thresholds may be lowered, but not increased.

# 3 REVISION OF THRESHOLD VALUES

- 3.1 The National Treasury has received numerous requests from institutions for the revision of these threshold values.
- 3.2 These thresholds which are applicable uniformly throughout all spheres of government were last determined in May 2005. In the spirit of co-operative governance, it has been decided that the requests for revision be considered through a collaborative process.

To this end, accounting officers / authorities are invited to submit proposals on the revised threshold values that should be applied when procuring goods and services by means of petty cash, verbal / written price quotations and competitive bids. It is imperative that accounting officers / authorities submit their proposals for the different values with detailed motivations. The proposals together with the motivations will be used to concertedly consider the possible revision of the current threshold values.

## 4 SUBMISSION OF PROPOSALS

Accounting officers / authorities are kindly requested to submit their proposals on the attached return template by **not later than 02 April 2007** to the National Treasury.
