MUNICIPAL INFRASTRUCTURE SUPPORT AGENT

1. PURPOSE

The purpose of this report is to provide information for provision of Personal Protective Equipment (PPE) and fumigation/decontamination of MISA offices in compliance with COVID 19 regulations concluded by the Municipal Infrastructure Support Agent (MISA) from March 2020 to 31 July 2020.

It seeks to provide a basis upon which the MISA Supply Chain Management Unit performed its procurement process in line with National Treasury Guidelines, Instruction Notes, MISA Supply Chain Management Policy, PPPFA and any other applicable rules and laws that provide guidance on appropriate method to conduct procurement activities.

2. BACKGROUND

On the 15th of March 2020, The President of the Republic of South Africa, Mr Cyril M Ramaphosa announced that the world was facing a medical emergency far graver than what was ever experienced in over a century. The World Health Organisation declared the coronavirus outbreak as a global pandemic. Given the scale and the speed at which the virus was expected to spread, it was clear that no country was immune from the disease or will be spared by its severe impact. As it has never before in the history of South Africa's democracy been confronted with such a severe situation, the South African government had to put in place drastic measures to contain the spread of the virus and to treat those infected.

The President then indicated that this situation calls for an extraordinary response and there can be no half measures. It is against this background that the Accounting Officer of MISA issued an instruction for the procurement of Personal Protective Equipment (PPE) and fumigation/decontamination of MISA offices to ensure safety of MISA employees.

MISA immediately embarked on procurement of the items listed above to ensure safety of the employees.

Procurement details in this regard are documented in 3 and 4 below.

3. SUMMARY OF EXPENDITURE RELATED TO COVID-19
